- 1. When calculating the cost of flight maintenance, the prices applicable at the time of departure of the aircraft are applied
- 2. Procedure for taxation by value-added tax of services rendered in domestic and international air transportation:
- 2.1. Fees for aircraft maintenance services are charged at the rates of fees (tariffs) and prices effective on the date of departure of the aircraft from the airport.
- 2.2. Value-added tax is applied at the rate of 0 percent, when performing services rendered at the airport, upon arrival and / or departure of an aircraft performing an international flight.
- 2.3. Value-added tax is applied at the rate of 20 percent, when performing services rendered at the airport, upon arrival and / or departure of an aircraft performing a domestic flight.
- 2.4. In the implementation of services for the provision of an air terminal complex, ground handling of aircraft, passengers, aircraft crews, handling baggage, cargo and mail; maintenance of aircraft provided at the airport upon arrival and (or) departure of an aircraft making a flight with a landing at an airport, having an international and domestic flight legs, taxation with value added tax is made at a rate of 0 percent on the international flight leg and 20 percent on domestic leg.
- 3. The price list is applied in accordance with the Order of the Ministry of Transport of Russia dated 02.05.2024 N 157
