

1. When calculating the cost of flight maintenance, the prices applicable at the time of departure of the aircraft are applied
2. Procedure for taxation by value-added tax of services rendered in domestic and international air transportation:

2.1. Fees for aircraft maintenance services are charged at the rates of fees (tariffs) and prices effective on the date of departure of the aircraft from the airport.

2.2. Value-added tax is applied at the rate of 0 percent, when performing services rendered at the airport, upon arrival and / or departure of an aircraft performing an international flight.

2.3. Value-added tax is applied at the rate of 22 percent, when performing services rendered at the airport, upon arrival and / or departure of an aircraft performing a domestic flight.

2.4. When providing services for the provision of an airport complex, ground handling of aircraft, passengers, aircraft crews, baggage, cargo and mail; aircraft maintenance services provided at the airport upon arrival and (or) departure of an aircraft landing at an airport with international and domestic flight sections, taxation The value added tax is carried out at a rate of 0 percent on the international leg of the flight and 22 percent on the domestic leg of the flight. When providing services for take-off, landing, taxiing, and parking of aircraft, as well as for transport security, the value-added tax rate is 0% if the departure from the airport is international and 22% if the departure from the airport is domestic.
